Carbon Fiber Racing Wheel Mud Plug Assembly Instructions

Parts Included:

Part	Quantity
Clear Polycarbonate Cover with 3 Stainless Steel Quick Fasteners and Retainers	1 per Mud Plug
Aluminum Tabs with Stainless Steel Springs	3 per Mud Plug

Tools and Supplies Required:

1. 7/16" Socket (1/4" Drive)
2. Ratchet and Extension (1/4" Drive)
3. Standard Screwdriver

Torque Specs: (NOTE: DO NOT EXCEED TORQUE SPECIFICATIONS)

Bead-Lock Ring – Tighten snug – hand tight with a 1/4" drive ratchet or 5 ft-lbs (60in-lbs) maximum.

Installation Instructions:

1. Locate the slots for the aluminum Mud Plug tabs and slightly loosen the 3 bead-lock ring bolts. It may be necessary to loosen the bolts adjacent to these bolts if tab does not go in easily. (This can be done with the tire inflated if care is taken to not loosen the bolts too much.)
2. Insert the aluminum Mud Plug tabs into the slots so they snap in.
3. Re-torque the bead-lock ring bolts to the recommended torque.
4. Install the clear polycarbonate cover and tighten the 3 Quick Fasteners by turning them 1/4 turn.
